He was previously a Rappaport Policy Fellow through the Harvard Kennedy School where he developed tools to help policymakers address the opioid crisis in Massachusetts, and he has previously consulted for the Recovery Research Institute at Mass General Hospital and Harvard Medical School where he was involved in a project to disseminate the latest evidence-based information and findings in addiction treatment and recovery research to a broad audience. He has published more than 10 academic papers and reports on substance use and addiction, mostly focused on the opioid crisis.
